| 2. | Evaluation and Qualification Criteria | <p>We would like to request for following clarification for the tender no.: OCBI/VTT/TVETE PHASE III/EQUIP/32/23-24 - please refer from page 54 to 56 in tender document</p> <p>In section III - Evaluation and qualification criteria Point (II) - if the bidder is not a manufacturer</p> <p>point (i) b - where you mentioned " In case the Bidder is a JV, average annual turnover of all members to the JV shall be added to determine the turnover of the Bidder "</p> <p>Whereas,</p> <p>in Point (III) - " If the Bidder is a JV, the evidence of demonstrated usage of Goods supplied in the past shall be in the name of the JV "</p> <p>We would like to request that if in JV - financial of all JV is to be considered individual and as JV for the evaluation, same way demonstrated usage of goods supplied in the past shall be considered in the same way individually or as JV. Because if we are doing JV first time, any company in JV will not be having past orders in the name of JV.</p> <p>We request you to consider our above concern and modify this clause as demonstrated usage of goods supplied in the past shall be considered on the name of any one company in the JV.</p> | <p>The requirement that the JV turnover will be 'the average of the members of the JV' and the requirement that 'the evidence of demonstrated usage of Goods supplied in the past shall be in the name of the JV' will remain the same and will be applied by the employer in the selection of the bidder.</p> |
